



County of Haliburton Notice of Public Meeting Concerning an Application for Consent

Take notice that the County of Haliburton Land Division Committee has received applications to cancel previous consent approvals.

Location: The lands to be merged are located on vacant lands on Loop Road (Part Lot 18, Concession 22, Geographic Township of Cardiff), located in the Municipality of Highlands East (see key map).

Purpose and Effect: The applications propose to cancel two previous consents and permit the parcels to merge and consolidate.

Public Meeting: The County of Haliburton Land Division Committee will be holding a public meeting as required under the *Planning Act*. The public meeting is an opportunity for the Committee to hear and consider comments related to the proposed consents. Any member of the public may speak in favour of or in opposition to the applications during the public meeting.

Appeals: If a person or public body has the ability to appeal the decisions of the Haliburton County Land Division Committee in respect of the proposed consents to the Ontario Land Tribunal but does not make written submissions to the Land Division Committee before it gives or refuses to give provisional consent, the Tribunal may dismiss the appeal.
