

By-Law Number 18-013

The Regional Municipality of Waterloo

A By-law to Amend By-law 10-030, A By-law Respecting Signs on Regional Roads, As Amended.

The Council of The Regional Municipality of Waterloo enacts as follows:

1. That subsection 1(d) of By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended, be deleted and replaced with the following:

“(d) “ground-mounted sign” means a sign upheld by no more than two wooden or non-metal supports constructed on or driven into the ground where each wooden or non-metal support is no greater than 7 cm or 2 ¾” by 7 cm or 2 ¾” in cross-section, or a sign upheld by a support located on private property such that the sign and support encroach into the road allowance no more than 1.0 meter;”
2. That subsection 1(r)(ii) of By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended, be deleted and replaced with the following:

“(ii) an “election sign” which means a sign advertising any person or political party participating in an election for public office or a sign advertising a position on a plebiscite or municipal question or a sign of a third party registered pursuant to any federal, provincial or municipal election legislation supporting a political party, candidate or position;”
3. That subsection 4(a)(ii) of By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended, be deleted and replaced with the following:

“(ii) 30.0 meters of a traffic control signal, crosswalk, bus stop sign or school bus loading zone; or”
4. That subsection 4(a)(iii) of By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended, be deleted and replaced with the following:

“(iii) 100.0 meters of a roundabout as measured from the outer edge of any crosswalk at the roundabout and away from the roundabout;”
5. That subsections 4(l) and (m) of By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended, be deleted and replaced with the following:

“(l) promotes discrimination on the basis of race, ancestry, place of origin, colour, ethnic origin, citizenship, creed, sex, sexual orientation, age, marital status, family status or disability;

(m) is obsolete and advertises an event that is over, a business or enterprise that is no longer conducted, or an activity, product, service or facility that is not in season or is no longer provided; or”
6. That subsection 4(n) be added to By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended:

“(n) is within 1.0 meter of any other sign under Parts III, IV, V, VI, VII, VIII, IX or X of this By-law on the Regional road.”

7. That subsection 8(d)(iv) of By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended, be deleted and replaced with the following:

“(iv) 30.0 meters of an intersecting road, measured from the nearest edge of the shoulder or the roadway if there is no shoulder;”
8. That subsection 9(b) of By-Law 10-030, A By-law Respecting Signs on Roads, As Amended, be deleted and replaced with the following:

“(b) has dimensions that are not more than 1.2 meters or 48 inches in sign width (side to side) and not more than 0.8 meters or 32 inches in sign length (top to bottom);”
9. That subsection 9(d)(vi) of By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended, be deleted and replaced with the following:

“(vi) 30.0 meters of an intersecting road, measured from the nearest edge of the shoulder or the roadway if there is no shoulder;”
10. That subsection 9(e) of By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended, be deleted and replaced with the following:

“(e) is the only election sign advertising the same person or their political party or supporting the same person through a 3rd party advertisement or a position on a plebiscite or municipal question, for each side of a Regional road between two consecutive intersecting roads;”
11. That subsection 10(d)(vi) of By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended, be deleted and replaced with the following:

“(vi) 30.0 meters of an intersecting road, measured from the nearest edge of the shoulder or the roadway if there is no shoulder;”
12. That subsection 11(b)(vi) of By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended, be deleted and replaced with the following:

“(vi) 30.0 meters of an intersecting road, measured from the nearest edge of the shoulder or the roadway if there is no shoulder;”
13. That subsection 12(d)(vi) of By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended, be deleted and replaced with the following:

“(vi) 30.0 meters of an intersecting road, measured from the nearest edge of the shoulder or the roadway if there is no shoulder;”
14. That subsection 13(d)(vi) of By-Law 10-030, A By-law Respecting Signs on Regional Roads, As Amended, be deleted and replaced with the following:

“(vi) 30.0 meters of an intersecting road, measured from the nearest edge of the shoulder or the roadway if there is no shoulder;”
15. This By-Law shall come into force and effect on March 29, 2018.

By-law read a first, second and third time and finally passed in the Council Chamber in the Regional Municipality of Waterloo this 28 day of March, A.D., 2018.
