

SECTOR DEFINITIONS

Council-Appointed Boards & Committees

**Recommendations from the named organization are required to fill these positions.*

Advisory Committee on Aging (ACOA)

Sector	Definition
Alberta Health Services Representative	An individual who is currently employed by Alberta Health Services.*
Golden Years Society Representative	An individual who is currently employed by or a member of the Golden Years Society.*
Senior-at-Large Indigenous	An Indigenous individual who is 65 or older and can represent the interests and perspectives of Indigenous Seniors in the region.
Senior-at-Large Rural	An individual who is 65 or older, resides in a rural community within the region, and can represent the interests and perspectives of Seniors living in rural areas.
Senior-at-Large Urban	An individual who is 65 or older, resides in Fort McMurray, and can represent the interests and perspectives of Seniors living in Fort McMurray.
St. Aidan's Society Representative	An individual who is currently employed by the St. Aidan's Society.*
Wood Buffalo Housing Representative	An individual who is currently employed by the Wood Buffalo Housing and Development Corporation.*
Wood Buffalo Senior Resource Committee Representative	An individual who is currently a member of the Wood Buffalo Senior Resource Committee.*

Animal Welfare Advisory Committee (AWAC)

Sector	Definition
Public-at-Large	An individual who has specific competencies in animal welfare, public education, or rural animal husbandry.
Registered Veterinarian	An individual who is experienced in companion animal health and standards of care.
Representative from Registered Animal Rescue Group	An individual who is a member of a society in good standing under the <i>Societies Act</i> or of a registered corporation focusing on animal rescue. Each Committee member in this position must be from different groups.



Assessment Review Board (ARB)

Sector	Definition
Municipal Member	An individual from the public at large, who serves as an impartial adjudicator in assessment complaint hearings. Successful completion of approved ARB training is required following the appointment of a Municipal Member.

Audit & Compliance Committee (ACC)

Sector	Definition
Public Member	An individual who is financially literate possessing a set of skills, experience and knowledge of financial matters that support informed and effective decisions, with skills in public sector accounting.

Combative Sports Commission (CSpC)

Sector	Definition
Combative Sports Knowledge or Experience	An individual who has knowledge or experience in contact sports, including boxing, kickboxing, martial arts and mixed martial arts.
Financial Knowledge or Experience	An individual who has knowledge or experience in financial management.
Law Enforcement Knowledge or Experience	An individual who has knowledge or experience in law enforcement (e.g., RCMP, Sheriff, Bylaw, security, or lawyer).
Public-at-Large	An individual who contributes their experience, perspectives, and expertise to support informed decision making and helps advance the commission's mandate in the public interest.

Community Identification Committee (CIC)

Sector	Definition
Public-at-Large	An individual who contributes their experience, perspectives, and expertise to support informed decision-making and helps advance the committee's mandate in the public interest.



Community Investment Program Approval Committee (CIPAC)

Sector	Definition
External Funding Organization Representative	An individual who is currently employed by an external funding organization.
General Business Community Representative	An individual who currently owns or operates a business in the region.
Indigenous Representative	An individual of Indigenous decent and ethnicity who can represent the interests and perspectives of Indigenous people in the region.
Oil Sands Industry Representative	An individual who is currently employed in the oil sands, or oil and gas industry.
Public-at-Large	An individual with no formal affiliation with any social profit organization, who contributes their experience, perspectives, and expertise to support informed decision making and helps advance the committee's mandate in the public interest.
Social Profit Organization Representative - Small	An individual who is currently employed for a social profit organization in the region with less than 5 full-time employees.
Social Profit Organization Representative - Large	An individual who is currently employed for a social profit organization in the region with more than 5 full-time employees.
Social Profit Organization Representative - Rural	An individual who is currently employed for a rural social profit organization in the region.

Community Standards Appeal Committee (CSAC)

Sector	Definition
Public-at-Large	An individual who is not an employee of the Regional Municipality of Wood Buffalo and serves as an impartial adjudicator in Community Standards complaint hearings.

Fort McMurray Airport Authority (FMAA)

Sector	Definition
Director-at-Large	An individual who contributes their experience, perspectives, and expertise to support informed decision making and helps advance the committee's mandate in the public interest.



Homelessness Initiative Strategic Committee (HISC)

Sector	Definition
Addictions and Mental Health Sector Representative	An individual who is currently employed in the addictions and mental health sector.
Downtown Business Community Representative	An individual who owns or operates a business in downtown Fort McMurray.
Indigenous Representative	An individual of Indigenous decent and ethnicity who can represent the interests and perspectives of Indigenous people in the region.
Local Funder Representative	An individual who is currently employed by a local funding organization.
Non-municipal Justice or Enforcement Representative	An individual who is currently employed in a non-municipal justice or law enforcement role.
Public-at-Large	An individual who contributes their experience, perspectives, and expertise to support informed decision making and helps advance the committee's mandate in the public interest.
Public Housing Representative	An individual who is currently employed in the public housing sector.

Municipal Policing Advisory Committee (MPAC)

Sector	Definition
Public-at-Large	An individual from one of the following groups: Black, Indigenous and persons of color (BIPOC), immigrants, 2SLGBTQI+, persons with disabilities, religious minorities, seniors, women, or youth.
Ward 1 Representative (Fort McMurray)	An individual who currently resides in Ward 1 (Fort McMurray).
Ward 2 Representative (Fort McKay, Fort Chipewyan, Fort Fitzgerald)	An individual who currently resides in Ward 2 (Fort McKay, Fort Chipewyan, Fort Fitzgerald).
Ward 3 Representative (Draper, Sapræ Creek Estates)	An individual who currently resides in Ward 3 (Draper, Sapræ Creek Estate).
Ward 4 Representative (Anzac, Conklin, Janvier, Gregoire Lake Estates)	An individual who currently resides in Ward 4 (Anzac, Conklin, Janvier, Gregoire Lake Estates).

Note: Ward representation encompasses First Nation Reserve Lands located within the Wood Buffalo or Fort Chipewyan RCMP detachment boundaries



Regional Advisory Committee on Inclusion, Diversity and Equity (RACIDE)

Sector	Definition
Public-at-Large	An individual with life experience, skills or some background in one or more of the fields of human rights, inclusion, and anti-racism. Individuals should also possess experience working with, or living experience within, at least one the following groups: Black, Indigenous and persons of color (BIPOC), immigrants and refugees, 2SLGBTQI+, persons with disabilities, religious minorities, seniors, women, and youth.

Regional Recreation Corporation Board (RRC)

Sector	Definition
Director-at-Large	An individual who contributes their experience, perspectives, and expertise to support informed decision making and helps advance the board's mandate in the public interest.

Subdivision and Development Appeal Board (SDAB)

Sector	Definition
Public-at-Large	An individual who is a resident of the Regional Municipality of Wood Buffalo, is not an employee of the municipality, and serves as an impartial adjudicator for subdivision and development appeal hearings. Appointees must successfully complete approved Subdivision and Development Appeal Board training after their appointment.

Wood Buffalo Business and Development Advisory Committee (WBBDAC)

Sector	Definition
Development Industry Representative	An individual who is currently employed in, or has experience and knowledge of the development, construction, or real estate sectors.
Fort McMurray Chamber of Commerce	An individual who is currently employed by the Fort McMurray Chamber of Commerce.*
Indigenous Representative	An individual of Indigenous decent and ethnicity who can represent the interests and perspectives of Indigenous people in the region.



Local Business Owners Representative	An individual that currently owns or operates a business in the region.
Northeastern Alberta Aboriginal Business Association (NAABA)	An individual currently employed by the Northeastern Alberta Aboriginal Business Association (NAABA).*
Tourism Representative	An individual who is currently employed in the local tourism sector.
Public-at-Large	An individual who contributes their experience, perspectives, and expertise to support informed decision making and helps advance the committee's mandate in the public interest.

Wood Buffalo Economic Development Corporation Board (WBEDC)

Sector	Definition
Director-at-Large	An individual who contributes their experience, perspectives, and expertise to support informed decision making and helps advance the board's mandate in the public interest.

Wood Buffalo Housing and Development Corporation Board (WBHDC)

Sector	Definition
Director-at-Large	An individual who contributes their experience, perspectives, and expertise to support informed decision making and helps advance the board's mandate in the public interest.

Wood Buffalo Public Art and Beautification Advisory Committee (WBPABAC)

Sector	Definition
Public-at-Large	An individual with experience, skills, and expertise in the fields of arts, culture, or community beautification.

Wood Buffalo Revitalization Advisory Committee (WBRAC)

Sector	Definition
Arts, Culture & Heritage Representative	An individual who is currently employed in the field of arts, culture or heritage.



Business/Developer Representative	An individual who currently owns or operates a business in the region or is employed in the development sector.
Indigenous Representative	An individual of Indigenous decent and ethnicity who can represent the interests and perspectives of Indigenous people in the region.
Public-at-Large	An individual who contributes their experience, perspectives, and expertise to support informed decision making and helps advance the committee's mandate in the public interest.
Recreation Representative	An individual who is currently employed in recreation sector.
Safety and Security Representative	An individual who is currently employed in the safety and security sector.
Seniors Representative	An individual aged 65 or older who represents the interests and perspectives of Seniors living in the Regional Municipality of Wood Buffalo.

Wood Buffalo Regional Library Board (WBRL)

Sector	Definition
Public-at-Large	An individual who contributes their experience, perspectives, and expertise to support informed decision making and helps advance the committee's mandate in the public interest.
