
Notice of Public Hearing for Minor Variance

Take notice that an application to the Committee of Adjustment has been submitted for a minor variance to the Township of Springwater Comprehensive Zoning By-law 5000 pursuant to Section 45 of the Planning Act, c.P.13, R.S.O. 1990 as amended for lands known municipally as **3494 Baldwick Lane** and legally described as East of Lot 21, Concession 13, former Township of Vespra, now in the Township of Springwater, being Roll No. 4341 010 008 08100.

The purpose and effect of the application is to seek relief from Comprehensive Zoning By-law 5000 to permit the construction of an attached Additional Residential Unit and the keeping of existing accessory buildings, with exceptions as follows:

1. A Maximum Gross Floor Area for an Additional Residential Unit within a Primary Dwelling of 106.8 square metres (1,149.6 square feet), or 68 percent of the Gross Floor Area of the Primary Dwelling, whereas section 3.48.2 a. permits a maximum of 40 percent;
2. A Front Yard Width of 8.1 metres (26.6 feet), whereas Section 33.3.14.1. c) requires 9.0 metres (29.5 feet);
3. An Exterior Side Yard Width of 0.9 metres (3.0 feet), whereas Section 33.3.14.1. c) requires 9.0 metres (29.5 feet);
4. A Maximum Lot Coverage of 20.2 percent, whereas Section 33.3.14.1. d) permits 20 percent;
5. A Maximum Exterior Side Yard Width of 0 metres for accessory buildings, whereas Section 33.3.14.1. h) requires 9.0 metres (29.5 feet); and
6. A Maximum Interior Side Yard Width of 0.8 metres (2.6 feet) for accessory buildings, whereas Section 33.3.14.1. h) requires 3.0 metres (9.8 feet).

A location map and concept plan are enclosed.

The Committee of Adjustment for the Township of Springwater will hold a hybrid meeting (in person at the Township Administration Centre and virtually via Zoom) to consider this application on **Wednesday, April 22, 2026, at 6:00 p.m.** The hearing will also be livestreamed on the Township's YouTube channel at: <https://www.springwater.ca/live>.

Any person may make a submission in support of, in opposition to, or ask a question regarding the proposed variance application. Written submissions are recommended and can be made to the Planning Department by email, regular post or the drop box located

at the Administration Building. Please ensure all written submissions include your name, address and the application number.

If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed application, you must make a written request to the Township of Springwater Committee of Adjustment by email, regular post or the drop box located at the Administration Building.

If you do not participate in the hearing or request notification of the Committee’s decision, it may proceed in your absence and, except as otherwise provided in the Planning Act and you will not be entitled to any further notice of the proceedings. Failure of the applicant(s) or their authorized agent to participate at any hearing may result in the automatic dismissal of the application.

A specified person or public body as identified in the Planning Act, R.S.O. 1990, c.P.13, as amended may appeal to the Ontario Land Tribunal with respect to any decision made by the Committee of Adjustment by filling with the Planning Department of the Corporation of the Township of Springwater with a complete notice of appeal setting out the reasons for the appeal and accompanied by the fee required by the Tribunal.

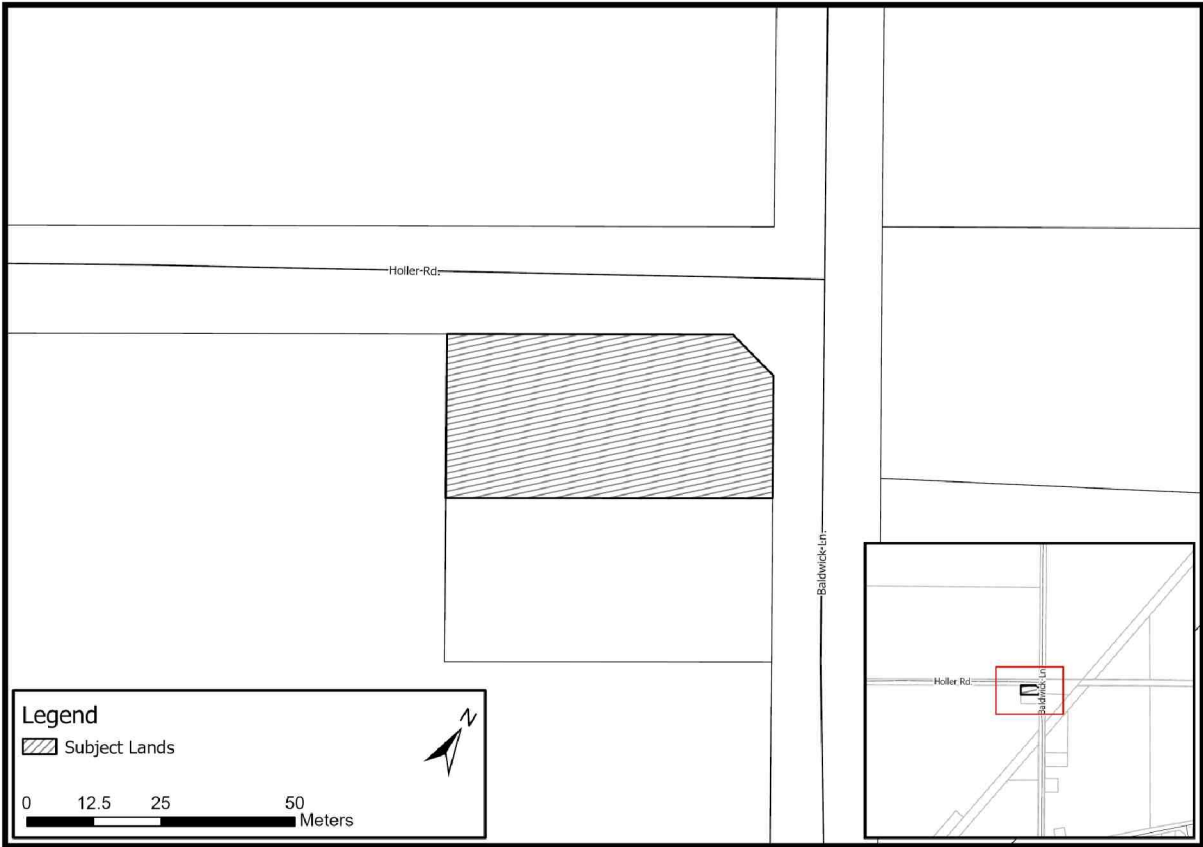
