**Alternative Voting (Online/Telephone):**

Electors can vote anytime from 9:00 a.m. on Friday, October 16, 2026 until 8:00 p.m. on Monday, October 26, 2026, using the eVoting system (i.e. Internet or telephone - no paper Ballots).

Each person on the Voters' List will be mailed, by "incentive letter mail":

- a sealed Voter Information Letter containing a Personal Identification Number (PIN),
- a telephone number to cast a vote, and the designated internet address (URL) to access to cast a vote using the internet
- instructions on how to vote;
- dates and hours of voting;
- the location(s) and telephone number of the Voter Help Centre(s), and the Voting Location(s) for in-person voting (internet alternative method)
- a list of Certified Candidates for office.

If a Voter Information Letter does not arrive in the mail by October 16, 2026, electors should visit or call the Municipal Office to verify or correct their status as electors. If qualified, a Voter Information Letter will be issued. The Voter Information Letter will be made available in English and French.

**In-Person eVoting/ Voter Help Centre:**

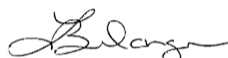
