	Corporate Registry Document - Required for properties owned by a corporation or numbered company to confirm signing authority.		
	Site Plan –When parcel coverage is more than 2m away from the property line - Including dimensions of proposed building and distances to the property lines. - Include dimensions of the lot and show all existing and proposed buildings and their uses on the property. - Identify all rights-of-way, covenant, and easement locations.		
	BC Land Surveyor Site Plan - by a Registered Land Surveyor - Required for new construction of any kind where parcel coverage is within 2 m of the property lines, covenants, easements, or statutory right of ways. - Include the same information as required on the site plan above.		
	Digital Detailed Drawings Including: - Foundation and floor plans, cross sections, elevation, dimensions, location of all plumbing fixtures, heating/venting, smoke/CO2 detectors, etc. All rooms labeled according to their use.
